#### I, Alexander R. Wheeler, declare as follows:

I am an attorney duly licensed to practice before all courts of the State of California and I am a Partner at the Parris Law Firm, attorneys of record for Plaintiff Brandon Campbell. The facts set forth in this declaration are within my personal knowledge and, if called as a witness, I could and would competently testify as follows.

- 1. On April 19, 2019, Plaintiff Campbell commenced his action against DoorDash, Inc. ("DoorDash") alleging that DoorDash's compensation scheme of using the delivery drivers' tips toward meeting their minimum-pay guarantee violates Labor Code sections 351 and 353.
